## Referral Agreement Terms

"CPS" CPS Web Design

"Referrer" Person or Business making referral

1. "CPS" agrees to provide services to the clients/contacts referred by the "Referrer".
2. "Referrer" acknowledges the following with respect to services:
  - a. "CPS" will confirm pricing, design and all other details directly with the Client/contact referred by the "Referrer".
  - b. "CPS" has no control over the policies of Search Engines & Third-Party Marketing Systems with respect to the type of websites and/or content that they accept now or in the future.
  - c. The "Referrer" acknowledges that "CPS" makes no warranty that the services will generate any increase in sales, business activity, profits or any other form of improvement for Client/contact referred by the "Referrer".
  - d. The "Referrer" can refer the Client/contact to "CPS" only once in any 2-year period.
  - e. "CPS" will pay commission only on the first sale of referred Client/contact.
  - f. The "Referrer" agrees to repay "CPS", using future commissions, if a Client/contact disputes a payment and is reimbursed by their bank after the payment date, at any time in the future.
3. "CPS" agrees to pay a commission to the "Referrer", which includes 10% of the actual sold Package Price amount charged to the Client/contact referred by the "Referrer", up to a maximum amount of \$500 per Client/contact referral. This is payable by, not negotiable, electronic funds transfer, as a lump sum at the end of month following "CPS" being paid in full.
4. Obligations of "CPS" & "Referrer".
  - a. "CPS" will perform all agreed services.
  - b. No liability whatsoever (except as provided by law) will be accepted by "CPS" for any damages or losses arising from or as a consequence of the provision of the Services or any other act or default on the part of "CPS" in relation to this agreement and the Services unless the same occurs because of the negligence of "CPS", in which case liability is limited to supplying the services. Nothing in this agreement is intended to limit or exclude any liability on the part of "CPS" where and to the extent that applicable law prohibits such exclusion or limitation.
  - c. "Referrer" will keep client/contact, customer data and payment details confidential.
  - d. The "Referrer" will indemnify "CPS" against all claims, demands, liabilities, damages, costs and expenses resulting from or connected with any claim of infringement arising out of the provision of services by "CPS"
  - e. Agreement can be cancelled at any time with 1 months' notice by either party.
  - f. This agreement is subject to the jurisdiction of the State of New South Wales, Australia and the parties irrevocably submit to the jurisdiction of the courts of the State of New South Wales.
